PRESENTATION OF INSURANCE POLICY by Joann Smith

CRIME POLICY RENEWED THROUGH UTICA MUTUAL

The current policy is held by Glat Feltner, whose projected policy comes in at \$25,509.09 for the upcoming renewal.

A competitive policy by HCC Public Risk (Tokio) is coming in at \$19,951.03.

A Cyber policy is not now included in packages and is being quoted separately at \$1150.00; a separate Crime policy is \$787.00. The HCC policy has more coverage on the buildings but has higher deductibles.

C1) NEW BUSINESS 7:00PM

NB1) Request from Stan Emert (in person) re: visibility at end of his driveway on Tarbell Rd/Pearl St. He feels his options are limited as NYSEG will not do anything to move the poles so he can have the bank dug back; the smaller pole is Frontier Communications. It was mentioned that the best solution would be to put a mirror up on the bridge across from the driveway to help with viewing up the road. Hwy Sup't Witkowski will purchase and install the mirror.

Mr. Emert also mentioned that water comes down from the solar farm property to the ditch next to the bridge, comes out of the ditch but can't go under the road or onto the bridge and so runs into his driveway. Hwy Sup't

Witkowski mentioned that is so because of the way the roads are, there is not much that can be done, maybe a flat top swale. He will work on that as well.

NB2) **Concern from residents and neighbors on Hammerle Rd** regarding rats from Smithville Center corner property now filtering onto adjacent properties. Supervisor Cammarata mentioned a couple of years ago a letter was sent to the corner property and it was cleaned up. Supervisor Cammarata will review the properties and write another letter to the CO RD 3 property.

It was also mentioned that a similar situation is occurring at the property near the intersection of Engaard Rd at Stone Quarry. Supervisor Cammarata said he would also write a letter to that resident.

NB3) Consider Resolution updating the Senior/Disability Exemption *

Assessor Faline Ward addressed the Board

The senior citizens low income and disability income was changed by the Governor, then a Local Law by Chenango County was created to support it. It is now up to the Town Board if they will change the low income level for the senior and disability exemptions and then decide whether to add any pension/IRA amounts received as income by the Senior/Disabled person back into the exemption calculations or not. This can be done by Resolution, the specific form of the Resolution has been added to the last page of the minutes. There are currently 8 people in the combined exemption program. After discussion the following Resolution was voted upon.

RESOLUTION #9 (2024): CHANGE THE LEVEL OF LOW INCOME SENIOR CITIZEN/DISABILITY EXEMPTION AND TAXABLE IRA'S OR PENSIONS WILL BE INCLUDED IN THE CALCULATIONS OF THE EXEMPTION

The above Resolution was ADOPTED at the February 19, 2024 meeting of the Smithville Town Board with the Town Board voting to change the levels of the low income Senior Citizen/Disability levels currently \$11,000. -\$16,700. to the new levels of \$15,000.-\$23,400. This was so moved by Board member Butler, 2nd by Board member Wark. Voting was consistent with 5 AYES: Board members Heisler, Butler, Wark, Whitmore and Cammarata voting.

An additional part of this Resolution also included adding back in the statement that taxable IRA's/Pensions will be included in the calculations of these Exemptions. This was so moved by Board member Butler, 2nd by Board member Heisler. Voting was consistent with 5 AYES: Board members Heisler, Butler, Wark, Whitmore and Cammarata voting.

The above Resolution was declared duly adopted. The full Resolution is provided in a separate document.

- Hwy Sup't Witkowski is still considering the purchase of a Brush mower/mulcher and is meeting with one more person this week. The item fitting the purpose which he is hoping to purchase is by Mongo and is similar to a flair mower which will enable the tractor to cut small trees in addition to brush at the sides of the road. A connection using a bracket for the rubber tired tractor, coupler for excavator can be purchased for about \$850. The cost of the Mongo flail mower is \$13,610. plus \$350. shipping.  - Budget on the light side due to CD's due May 3rd @ 4%
 - The tentative start date for N. Tyner Rd is June 3rd. Midwest Industries is sending out a product truck and a spray truck to re-surface the road with a polymer stabilizer which will last 8-10 years. This will be an approx. cost of \$97,781. compared to 160K to pave it. Suite Kote will do the stone and oil topping later on. This process will be reimbursable through CHIPS.
 - There is also a dust product either in place of calcium of or in addition of. A tote of solution costs \$3836.25 but the Town will have to purchase the spray system at a cost of \$5500. The product is environmentally safe, dries like calcium; 1 gal will do a 55' long x 10' wide patch which is better than calcium. More study will be put into this process before making a decision.
 - Supervisor Cammarata said the Budget will be changed next year so that all Highway expenses will be on the Highway side of the budget; anything with the Community Center will go on the General Side
 - A motion to accept the Supervisor's report was made by Board member Whitmore, 2nd by Boardmember Wark. All 5 Board members: Heisler, Butler, Wark, Whitmore and Cammarata were in favor, motion carried.

A motion to approve the January 15th minutes was made by Board member Butler 2nd by Board member Whitmore. All 5 Board members: Heisler, Butler, Wark, Whitmore and Cammarata were in favor, motion carried.

General Warrant # 2, Vouchers # 9-24 in the amount of \$6,354.99 were submitted for payment. All credit cards, utilities have been changed to a common due date.
