# **RESOLUTION # 1 (2024)**: ACCEPT RESIGNATION OF TOWN CLERK ELECT PHILIP MONTELIONE

NB3) Planning Board considerations for appointment: 2 candidates have submitted applications for consideration to the Planning Board: Karen Cammarata and Ken Whitmore. This was discussed at length but a decision was finally made in favor of Ken Whitmore.

## **RESOLUTION # 3 (2024):** APPOINT KEN WHITMORE TO THE PLANNING BOARD WITH A 1YR TERM

## **RESOLUTION # 4 (2024):** APPROVE THE TOWN ROSTER FOR 2024 WITH EXCEPTIONS

RESOLVED to approve the 2024 Town roster with the exception of Deputy Code Enforcement Officer and Court Clerk.

NB6) Review of the 2023 Town Fee Schedule for changes

- It was recommended to change the septic application fee to \$50.00 per application
- The SPCA and any potential contract is still up in the air so the \$75.00 Redemption fee was left as is. DCO Roger Barrows can keep a dog for 24 hours at his residence. The dog license fees will remain the same for 2024.
- Other changes were discussed including whether the Road Use Local Law should have a 3 month permit rather than a per job fee; also it was asked if the amount should be listed on the application for the bond. This will be discussed at the January 15th meeting.

#### **RESOLUTION # 5 (2024)**: APPROVE THE TOWN FEE SCHEDULE FOR 2024

Other items discussed:

- The submission of the FEMA paperwork was pushed back due to errors. It could be extended.
- The Cazenovia Equipment warranty expired before the signed contract was paid for. Supervisor Cammarata is working with John Deere to see if they would still honor it or a lesser form of it.
- The FEDEX billing is also still in limbo as to the amount quoted and the bill received.
- It was mentioned some of the street lights are on again, off again
- With the clear weather and unfrozen ground, they Hwy Dept should be utilizing the time to do ditching
- The Gradall transmission is still not fixed
- Williams Road still has problems despite being repaired
- The water system was also discussed. There is a possibility a well site can be located on property belonging to the DeJagers on Co Rd 3. The low income survey is still in the process of being done. There was some concern about the total cost of the water system when the time comes for commitment to installation. Other Board members were concerned about the hamlet wells and septic systems being on top of one another. Individual water filtering systems were mentioned as a possibility

There was no other business to come before the Board. Supervisor Cammarata declared the meeting adjourned at 7:40pm until the regularly scheduled meeting January 15, 2024.
